The Department of General Services' (DGS), Bureau of Diversity, Inclusion and Small Business Opportunities (BDISBO) develops and oversees programs to promote small diverse business (SDB) and small business (SB) participation in Commonwealth contracting opportunities and provides assistance, education, training and support on doing business with state government agencies.

The Bureau performs proactive compliance auditing to ensure open and equitable contracting practices are utilized, contractual commitments are realized and allegations of abuse, false certification or discriminatory practices are investigated. As part of our compliance review, BDISBO will be monitoring and tracking Small Diverse Business and Small Business utilization to ensure commitments made by the Job Order Contracting (JOC) prime contractors are met on an *annual* basis. The chart below provides information on the contractual obligations to Small Diverse Businesses and Small Businesses for each of the JOC prime contractors
