## **COSTARS Helps Its Members Save on Green Procurement**

In recent years, many organizations throughout the commonwealth have developed "green" initiatives to advance the protection of our environment and support sustainability for future generations. In the same manner, the Department of General Services Bureau of Procurement makes environmentally preferable procurement one of its predominant goals. Environmentally preferable procurement (EPP) or green procurement is the selection of products and services that have a lesser or reduced impact on the environment over the life cycle of the product or service when compared with competing products or services serving the same purpose.

When selecting green products, the Bureau of Procurement takes into consideration many factors including: the reduction of greenhouse gas emissions and air contaminants; improved energy and water efficiency; reduced waste and support of reuse and recycling; the use of renewable resources; reduced hazardous waste; and reduced toxic and hazardous substances.

DGS policy is to analyze each commodity and service during the bid process to determine what EPP options are available. The "green" option is utilized whenever the product or service is comparable in quality, availability and price. Did you know there are many COSTARS-exclusive and statewide COSTARS-participating contracts that include products and services to support your organization's green initiative plans? (see sidebar).

Several state agencies have developed programs to realize the commonwealth's ongoing green/sustainability goals. The GreenGov Council, co-chaired by the Secretaries of the departments of General Services, Environmental Protection, and Conservation and Natural Resources, works with state agencies to promote best practices and success in achieving the energy efficiency and performance goals initiated by Governor Wolf in Executive Order 2019-01 "Commonwealth Leadership in Addressing Climate Change and Promoting Energy Conservation and Sustainable Governance."

This order established the first greenhouse gas (GHG) reduction goal for the commonwealth: 26 percent reduction of net GHG emissions statewide by 2025 from 2005 levels, and an 80 percent reduction by 2050 from 2005 levels. Governor Wolf also released the **Pennsylvania Climate Action Plan 2018** (https://www.dep.pa.gov/Citizens/climate/Pages/PA-Climate-Action-Plan.aspx) that identifies more than 100 actions state and local government leaders can take to reduce greenhouse gas emissions.

To support municipalities and counties in this effort, the Pennsylvania Department of Environmental Protection (DEP) Energy Programs Office launched the Local Climate Action Program (LCAP) in 2019. Funded by the State Energy Program of the U.S. Department of Energy, this DEP program trains college students across the state to assist municipalities — boroughs, townships, counties, and cities — in developing local GHG inventories, climate-related vulnerability assessments, and climate action plans over the course of one year. "The program is a win-win, whereby students receive real-world experience and local governments get the gift of human capital," said Heidi Kunka, DEP Energy Program Specialist.

Additionally, the GreenGov Council provides a variety of resources available to local governments including the GreenGov Council & Penn State Sustainability Institute's **Sustainability Series Webinars**, biannual stakeholder meetings, and a quarterly e-newsletter that highlights recent efforts in energy efficiency and conservation, use of clean fuels and renewable energy, and benchmarking to meet ambitious goals in carbon dioxide emissions reduction. "The Council encourages local governments (stakeholders) to participate in biannual stakeholder meetings and sign up to receive the newsletter," said Mark Hand, director of the GreenGov Council.

## New! Electric Vehicle (EV) Charging Stations Contract

According to the Edison Electric Institute and the Institute for Electric Innovation, by the year 2030, there may be as many as 19 million plug-in electric vehicles (EVs) on the road in the U.S., representing a market share of 10 percent.

In 2019, the U.S. Department of Environmental Protection provided recommendations for effective implentation of EV-ready commercial buildings enabling building owners and managers to add value to properties, increase the convenience and affordability of driving EVs for tenants and employees, and show leadership in adopting advanced, sustainable technologies. Recommendations for EV-Ready Commercial Buildings include:

- Evaluate the need for EV charging. Plan for the future assume that demand will increase and that charging system expansion will be needed.
- Determine power availability and the number of EV chargers needed.
- Work through additional project steps. Contact EV charger providers; ask for energy efficient, ENERGY STAR certified models and discuss your project needs. Work with a certified electrical contractor to carry out the installation of EV charging at your facility according to local and National Electric Code requirements.
- Market your EV charging commitment. Advertise charging station availability to current tenants as well as to prospective new tenants as a key amenity of the building<sup>2</sup>

To support the commonwealth's increasing need for EV charging stations, a new solicitation was posted in January for the **Electric Vehicle (EV) Charging Station ITQ #4400023919**. Suppliers are currently being solicited for this contract. Additionally, this is a COSTARS-enabled contract, allowing awarded suppliers to expand their market to more than 9,000 registered COSTARS members.

## Higher Ed. Gearing Up for Budget Challenges

A study by the International Association of University Presidents and Santander Universidades recently found that colleges will feel the affects of the pandemic for quite some time. Due to the pauses of in-person education in 2020, collegiate revenue has been on a decline. Not only has lower enrollment caused a dip in revenue but also the loss of connected revenue generated by housing and food service has affected the budgets of our higher education providers. Colleges and Universities will need to be innovative to recover this lost revenue.

One possibility for these entities, not already involved in this \$1 billion industry, is to explore adding varsity eSports to their collegiate offering. eSports are multiplayer video game competitions, either played as head-to-head matches by individuals or as teams. According to the National Association of Collegiate eSports (NACE), varsity eSports programs are offered by more than 170 higher education institutions in the United

States. In addition, NACE reports that potential students have scholarship opportunities—to the tune of a combined \$16 million in scholarships per year. A collegiate eSports program can help higher education institutions drive enrollment with STEM and international students.

We have all had to make adjustments during 2020 and devise ways to be efficient in a new environment, with limited resources or support staff. While the COSTARS team has been teleworking, our press office sends weekly Teleworking Tips. We thought our COSTARS members and program participating suppliers might find these as helpful as we have. Enjoy!

#### Microsoft Office:

- Word—Delete entire words at a time = Ctrl+Backspace (curser placed after word to be removed)
- Word—Insert links = Ctrl+K
- Excel—Wrap text in a cell = Wrap Text option under Home tab or Alt+Enter
- **PowerPoint**—Start slideshow from beginning = F5
- PowerPoint—Write on your slides while presenting = Ctrl+P
- PowerPoint—Highlight on your slides while presenting = Ctrl+U

#### Windows 10:

- Pin the Sticky Notes app to your task bar to jot down a phone number or create a note quickly.
- Perform calculations on dates using the Date Calculation in the Calculator by clicking on the three lines in the top right of the app.
- Delay a screenshot in Snip & Sketch by clicking the small arrow next to New and choose the delay time.
- Want to clear the clutter of too many open windows on your screen? Grab the top
  of the window you want to keep and shake it. All other windows will minimize.
  Shake again to maximize windows.
- Don't have dual monitors? Get additional desktops virtually by clicking on Task

#### **FEBRUARY**

LNP Lancaster Online - The school board voted in July to replace the football field with synthetic turf, repair the rundown track and install a new stadium fence at its high school. To save on construction costs, board members approved a motion to participate in the state Department of General Services' COSTARS program. District officials expect to save \$345,000 by replacing the stadium scoreboard and switching to LED lighting.

**Observer-Reporter -** Washington City Council agreed during a Thursday virtual meeting to purchase a new plow truck after one of four recently broke. The truck will be purchased from Stephenson Equipment through the COSTARS Program.

The Citizen's Voice & Sunday Voice - Lake-Lehman School District has a contract for the completion of an athletic facility improvements project that will add new multi-sport fields on the high school campus by the football stadium. The school board approved a design/build contract with Keystone Sports Construction in Exton through the state COSTARS program.

agreement with Corbett Inc., of Norristown, "provides for social distancing furniture and barriers" inside "the courthouse, One Montgomery Plaza and" the offices inside the county's Office of Public Health. According to the contract, the equipment was available via the Commonwealth of Pennsylvania's cooperative purchasing program COSTARS.

The Mercury - Montgomery County Board of Commissioners authorized the purchase of maintenance equipment that will be distributed to the county's parks, trails and historic sites, and roads and bridges departments. The equipment will be purchased from Deere & Company, Eagle Power and Equipment and John Deere Shared Services. Additionally, a three-year agreement with CDW Government Inc., provides CommVault Data Back-up Software for Montgomery County's Information and Technology Solutions Department. An agreement with Whitmoyer Auto Group of Mt. Joy,

Pennsylvania, permits stakeholders from the Montgomery County Sheriff's Office and the Montgomery County Correctional Facility to purchase three 2021 Ford Police Interceptors. All purchases will be made through the COSTARS Program.

**The Meadville Tribune** -The Cambridge Springs Borough Council recently received a 2020 Ford Police Interceptor that was ordered in July from Bill McCandless Ford in Mercer through COSTARS.

**TribLive** - North Huntingdon police will be getting two new police cars this year. Township commissioners approved payment for two 2021 Ford police Interceptor Pursuit all-wheel-drive vehicles from Jim Shorkey Auto Group of North Huntingdon through the state's cooperative purchasing agreement COSTARS.

#### **DECEMBER**

**The Standard Speaker** - The Hazle Township Supervisors will use funds from a state Greenways, Trails and Recreational Program grant to replace a four-foot-wide wooden bridge at Lake Irena in Community Park with a 8-foot-wide bridge that can support motor vehicles. The bridge was purchased from the Contech firm through the state's COSTARS cooperative purchasing program.

#### **NOVEMBER**

The Mercury - The Montgomery County Commissioners authorized a series of contracts related to mitigation and response efforts surrounding the COVID-19 pandemic. A contract with Norris Sales Company Inc., of Conshohocken, provides for "16 Variable message sign board trailers." According to the agreement, the equipment was made available by way of a contract from the Commonwealth of Pennsylvania's cooperative purchasing program COSTARS. An agreement with Corbett Inc., of Norristown, "provides for social distancing furniture and barriers" inside "the courthouse, One Montgomery Plaza and" the offices inside the county's Office of Public Health. According to the contract, the equipment was available via the Commonwealth of Pennsylvania's cooperative purchasing program COSTARS

**Times Leader** - The Luzerne County Convention Center Authority approved upgrades and improvements at the Mohegan Sun Arena at Casey Plaza in anticipation of reopening the facility sometime next year. Some of the items will be purchased by ASM Global through COSTARS, the state's cooperative purchasing program.

**The Standard Speaker** - Hazle Township is using part of a COVID-19 grant to build a facility for storing PPE, sanitizing equipment and highway department trucks and equipment near the existing township garage, he said. A contract for that project was awarded through a state-run cooperative purchasing program COSTARS.

## DGS Provides Increased Opportunities for Small, Small

**Diverse and Veteran Business Enterprise**

The Commonwealth of Pennsylvania is committed to providing opportunities for small, small diverse, and veteran businesses to compete in state contracting with the goal of promoting economic growth and success of those small, small diverse and veteran businesses.

The Department of General Services (DGS), Bureau of Diversity, Inclusion and Small Business Opportunities (BDISBO) administers the Small Business (SB), Small Diverse Business (SDB), and Veteran Business Enterprise (VBE) programs which support small businesses and those small businesses that are minority, women, veteran, service-disabled veteran, LGBT-owned, and disability-owned business entities in their efforts to participate in Commonwealth contracts.

The SB, SDB, and VBE programs strive to increase opportunities for small and small diverse businesses to compete as both prime and sub-contractors for commonwealth contracts and enables them to compete on a more level playing field.

The Bureau administers a proactive compliance review program for monitoring utilization to ensure that contractual commitments between prime contractors and SB, SDB, and VBE sub-contractors are met. Finally, BDISBO conducts outreach and training to expand and enhance the program.

#### Requirements/Eligibility:

Businesses interested in participating in the Small Business Program must first register to do business with the Commonwealth, obtain a PA Vendor Number, and self-certify through an online application as a "small business."

To self-certify and participate in the program, a business must meet each of the following requirements:

- The business must be a for-profit, United States business.
- The business must be independently owned.
- The business may not be dominant in its field of operation.
- The business may not employ more than 100 full-time equivalent employees.
- The business may not exceed \$38.5 million three-year average gross revenues.
- The business must provide the company's three most recent federal tax returns.

The opportunity for Small Diverse Business and Veteran Business Enterprise verification is offered once a business has received a PA Vendor Number and is successfully self-certified with the commonwealth as a small business.


