REQUEST FOR INFORMATION

- 1. Please provide a list of all equipment available (kitchen equipment, mechanical equipment, laundry room equipment, etc.). A list of kitchen and laundry equipment is attached to this bulletin as Attachment A. A list of HVAC equipment list is being gathered.
- 2. Please explain the storm water infiltration ECM in more detail. **During times when the** institution receives high amounts of rain, they tend to discharge more sewer water than domestic water that they take in.
- 3. What are the extents of the Chilled Water expansion? **Expansion will be to all buildings** that currently do not have air conditioning, which are: A, B, C, E, F, Gym, Activities, Chapel, Education.
- 4. Is there a Controls/Automation standard or specification that needs to be met? **Currently, the institution does not have a centralized control system.**
- 5. What is the capacity of the CNG plant? 105,000 scf/hr, 3 trailers at 360,000 cf each
- 6. Relating to ECM 2 (Replacing Absorption Chiller), DGS indicated during the kickoff that a size had been determined for its replacement as it relates to this project and not to the future capital project, can details be provided? **This is still being negotiated between DOC and DGS.**
- 7. Relating to ECM 1 (Above Ground Piping), can DGS or DOC provide the necessary security requirements for the structures and piping? **Piping must go under or through fencing; when going through, it must be wrapped in razor wire to**

prevent tampering with the fence or act as a climbing aide. If piping goes up the outside walls of a building, it must have razor wire on it to prevent climbing; any structure that could act as a ladder will need to have razor wire on it.

- 8. Can SCI Frackville provide a site overview of areas within the fence that are considered higher priority for security to understand the outdoor operations and impact to potential scope items? For instance, areas that are considered high security in which maximum level security measures must be included, or areas where there are minimal requirements due to limited occupant accessibility. **Housing units E and F would be areas where higher security measures must be utilized.**
- 9. Are pictures/digital copies of the site drawings available? Basic drawings are available in the same SharePoint site that contains the site visit photos. However, currently, more complex drawings such as mechanical and electrical drawings, are not available electronically.
- 10. During the pre-proposal conference, DGS stated that the evaluation/scoring committee will consist of two (2) representatives from the Dept of Corrections (DOC) and (1) from the Department of General Services (DGS). Are DOC evaluators based solely at SCI Frackville or do they also manage other SCIs located throughout the Commonwealth? The evaluators are not based solely at SCI Frackville.
